

ARTICLES OF INCORPORATION OF STEP BY STEP SPECIAL NEEDS ACADEMY, INC. A NOT-FOR-PROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a not-for-profit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation shall be:

STEP BY STEP SPECIAL NEEDS ACADEMY, INC.

The address of the principal office of this corporation shall be:

ARTICLE II

Said corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding Sections of any prior or future Internal Revenue Code, or to the Federal.
