It has been brought to my attention that a gentleman named Neil Brown has made himself the Registered Agent for **Wesley Brotherhood Inc** of Florida. Neil Brown is in no way associated with our ministry. Neil Brown is also attempting to Trademark our ministry's logo in Florida, which is on violation of 2023 Florida Statutes Title XXXIII 495.121 entitled Fraudulent Registration.

This is not the first time we have had to deal with Mr. Brown's actions. He refuses to acknowledge emails, phone calls, texts, and multiple overnight letter attempts.

These two things happened this summer w/ the North Carolina Office of the Secretary of State:

- 1. Neil Brown attempted to form a North Carolina-based corporation named Wesley Brotherhood while linking it with our Florida-based ministry, which has Non-Profit status. The end result was the corporation was withdrawn.
- 2. He did the same thing with their Trademark Office. We provided the proper documentation, and the end result was they rejected the Wesley Brotherhood logo from their Trademark Office. I believe you can get more information from the North Carolina Trademark Office by speaking with Ms. Deborah Butler in Raleigh at 919.814.5361 or you can email her at dbutler@sosnc.gov.

And now we receive a letter from you (copy attached) and we see Neil Brown is trying to trademark our logo. That made us review our ministry's information in Florida. We see Neil Brown has gone online and followed the steps to make changes to the leadership with the Florida Secretary of State's office. He claimed he was the Registered Agent and both Dan Davis and I had resigned. That is all false information. Neither Dan Davis nor I resigned. *Neil Brown is not associated with Wesley Brotherhood Inc of Florida*.

How do we keep him from doing this again in our home state of Florida? Is there a way to make sure he never tries to become the Registered Agent again or files a trademark? Is there some way to put in Wesley Brotherhood Inc's electronic files that Neil Brown is not associated with Wesley Brotherhood Inc?
