ADDITIONAL PROVISIONS TO

ARTICLES OF INCORPORATION OF

REDEMPTION CHURCH OF FLORIDA, INC.

DISSOLUTION CLAUSE

Dissolution means the complete disbanding of the Corporation so that it no longer functions as a corporate entity. Upon the dissolution of the Corporation, its property shall be applied and distributed as follows:

- (1) All liabilities and obligations of the Corporation shall be paid and discharged, or adequate provision shall be made, therefore.
- (2) No part of the corporation's earnings or assets shall inure to the benefit of any of its members. Assets of the corporation shall be transferred or conveyed to one or more domestic or foreign corporation, society, or organization that qualify as exempt organizations under section 501 (c)(3) and are engaged in activities substantially like those of the corporation.

OPERATION PROVISION

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person.

The specific purpose for which this corporation is established is to organize a church (place of worship) modeled after the early Biblical, Christian community as recorded in the book of Acts, for the advancement of the Gospel of Jesus Christ by all available means. The church will be a place of worship, teaching, preaching, and conducting evangelistic and compassionate outreach both in local and foreign communities. It will also license and ordain ministers of the gospel and will provide Christian fellowship for those of like faith where Jesus Christ may be honored.
