

### Article of Incorporation of

### THE OBSTACLES OF LUPUS ORGANIZATION Inc.

Said organization is organized exclusively for charitable, religious education and scientific purposes, including for such purposes, the making of distribution to organizations that qualify as exempt organizations under Section 501(c) (3) of Internal Revenue Code or corresponding section of any future federal tax code. The business activity for said organization is as follows. The Obstacles of Lupus Organization Inc. is dedicated to improving the quality of life for all people affected by lupus through programs of research, education, support and advocacy.

No part of the net learning of this organization shall Ensure to the benefit of Or be distributable to its members trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay personal compensation for services rendered and to make payments and distributions and furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in or intervene in (Including the publishing or distribution of all statements). Any Political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) By a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue code or the corresponding section of any further federal tax code or (b) by a corporation, corporations to which our deductible under Section 170 (c) (2) two of the Internal Revenue code or corresponding section of any future federal tax code.
