

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be Tohopekaliga Band Boosters, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The organization is organized and operated for the charitable purpose of supporting the Tohopekaliga Band students achieve their musical goals, inclusive of the various areas of the Tohopekaliga High School Band Department, namely: various Concert Bands, Jazz Bands, Solo & Ensemble groups, Band Color Guard/Flag Corp, Marching Band, Pep Band, Musical Pit Orchestra, and any other group under the direction of the Tohopekaliga High School Band Director, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. In pursuance of these purposes, it shall do all things necessary, proper, and consistent with maintaining tax exempt status under section 501 (c)(3).



Upon dissolution of the corporation, its assets shall be disposed of exclusively for the purposes of the corporation or distributed to such organizations organized and operated exclusively for charitable purposes which shall, at the time, qualify as exempt organizations under section 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose.
