

## FIRST AMENDMENT to ARTICLES OF INCORPORATION of LEGACY GOLF CLUB, INC., a Florida not-for-profit corporation

At a duly noticed meeting, held on June 4, 2022, the Board of Directors of the LEGACY GOLF CLUB, INC., a Florida not-for-profit corporation (the "Corporation"), unanimously adopted the following amendment to the Articles of Incorporation of the Corporation, in accord with section 617,1006, Florida Statutes.

Article IV of the Articles of Incorporation of the Corporation, filed April 12, 2022, is deleted and replaced with the following:

## ARTICLE IV - Membership
