

The purposes for which this Corporation is formed are as follows:

VOLUSIA SCHOOL FOR AUTISM, INC., is a not-for-profit educational organization providing individuals on the autism spectrum and/or with speech-language impairment specialized education using innovative and varied modalities of instruction and alternative communication to develop or improve capabilities, including teaching, specialized tutoring, educational therapy, individualized academic support and small class sizes with low teacher-student ratios to foster academic and holistic success in students from elementary to high school and beyond (K-22+) in a nurturing environment that cultivates Judeo-Christian character traits that help develop good citizenship; said corporation is organized exclusively for educational purposes.

ARTICLE IIIB. DEDICATION OF ASSETS.

The properties and assets of this not-for-profit Corporation, VOLUSIA SCHOOL FOR AUTISM, INC., are irrevocably dedicated to educational purposes. No part of the net earnings, properties, or assets of this Corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual, or any member, director or officer of this Corporation. On liquidation or dissolution, all properties and assets, and obligations if any, shall be distributed and

paid over to an organization dedicated to similar charitable, religious and/or educational purposes, which has established its tax-exempt status under Internal Revenue Code Section 501(c)(3).


