The following language relates to the Corporation's tax-exempt status and is not a statement of purposes and powers.

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code for the corresponding section of any future federal tax code.

No part of the net earnings of the Corporation shall insure to the benefit of the distributable to its members, trustees, officers, or other private persons, except the the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forthing the purpose clause. No substantial part of the activities of the Corporation shall be the carry part of propaganda or otherwise attempting to influence legislation and the Corporation shall be the carry participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
