The Corporation shall not engage in any act of self-dealing as defined in the Internal Revenue Code. The Corporation shall not retain any excess business holdings as defined in the Internal Revenue Code.

**ARTICLE XII – INDEMNIFICATION**

The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

**ARTICLE XIII – DISTRIBUTIONS UPON DISSOLUTION**

**ARTICLES OF INCORPORATION**  
*In compliance with Chapter 617, F.S. (Not for Profit)*

**ARTICLE I - NAME**
