Nonprofit Purpose: This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section 2. Specific Purpose: Redefine Ministries is a faith based not-for-profit organization formed to serve women, assigned

female at birth, sixteen years and older that have experienced some sort of trauma in their life. We aim to help women achieve upward mobility and create a wellness-driven approach to life. We envision communities empowered by healed and self-sufficient women. As our slogan states, we have been formed to "redefine women's life from the inside out", making sure that all aspects of our lives are addressed; physical, mental, and spiritual. The business model for the organization revolves around our outreach, education programs, and physical and mental wellness checks.

Dissolution Clause: Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


