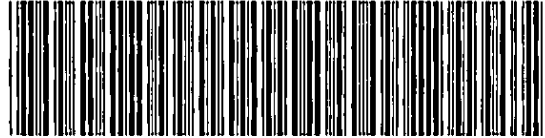

**ARTICLES OF INCORPORATION
VAISHNAVA INTERNATIONAL RELIEF
ASSOCIATION, INC.**

ARTICLE I: NAME

The name of this corporation is Vaishnava International Relief Association, Inc.

ARTICLE II: PRINCIPAL PLACE OF BUSINESS

The principal place of business of the corporation is 20415 NW 113th Way, Alachua, FL 32615.

ARTICLE III: PURPOSE

The purpose of the corporation is to facilitate strategies that encompass strengthening society through the protection of the innocent, networking of the business community and individuals, and supporting spiritually-minded leadership in a progressive and dharmic way.

ARTICLE VII: REGISTERED AGENT

ARTICLE VIII: LIMITATIONS

- (a) This corporation is organized and operated exclusively for charitable and/or religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, and is not for the gain of any private person.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
- (c) No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation; nor shall the corporation participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE IX: PROPERTY DEDICATED TO CHARITABLE AND/OR RELIGIOUS PURPOSES

The corporation's property is irrevocably dedicated to charitable and/or religious purposes, and no part of the net income or assets of this corporation shall inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable and/or religious purposes, and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

ARTICLE X: INDEMNIFICATION

No member, officer, director or employee of the corporation shall be personally liable for any corporate debt or liability of the corporation, and the corporation shall provide in the bylaws for the indemnification of such persons for certain of their acts or failures to act when undertaken for or in the interest of the corporation and in good faith.

ARTICLE XI: DURATION

The duration of the corporation shall be perpetual.

ARTICLE XII: INCORPORATOR
