

## ARTICLES OF INCORPORATION OF ARTICLES OF INCORPORATION FOR SWEETBARB ESTATES OWNERS ASSOCIATION, INC.

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a nonprofit corporation.

#### ARTICLE I

The name of the Corporation is: Articles of Incorporation for Sweetbarb Estates Owners Association, Inc..

#### ARTICLE II

The existence of the Corporation shall begin on the date these Articles of Incorporation are accepted by the Florida Department of State, as evidenced by the department's endorsement of the date and time of filing.

#### ARTICLE III

The street address of the principal office of the Corporation is: 908 Gardengate Circle Pensacola, Florida 32504.

#### ARTICLE IV

The specific purpose for which the Corporation is organized is: to create an entity which can provide for maintenance and architectural control of Sweetbarb Estates Subdivision (the "Subdivision") and common properties and architectural control of the residential lots within that certain tract of property described as follows, to-wit:

#### ARTICLE V
