ARTICLES OF INCORPORATION FOR LOVE SHARE RESCUE OUTREACH, INC.

The foregoing document is for the purpose of forming a nonprofit Corporation in compliance with *Florida State Statute §617* (Corporations Not for Profit).

Article I - Name

The name of the Corporation is be Love Share Rescue Outreach, Inc. (hereafter referred to as the "Corporation")

Article II – Incorporation Date

The Corporation shall have perpetual existence. The date and time of the commencement of corporate existence is the date of filing these articles with Florida's Department of Corporations.

Article III - Principal Office

The Corporation shall be established, maintained, and have the mailing address at 1828 Upper Road, in the City of Wesley Chapel, County of Pasco, with zip code being 33543 and in the State of Florida. The Corporation may have offices and in other places within or outside the State of Florida.

Article IV - Purpose

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under I.R.C. §501(c)(3), or the corresponding section of any future federal tax code. The Corporation is organized to provide food for the families in need, elderly, homeless, disabled veterans, and animal rescues.

Article V - Mission

To create a healthy relationship "sandwiched between" people and animals through food and rescues: Love Share Rescue Outreach serves the community in partnership with other nonprofit organizations. We invest in average families through food rescues. We pick up high-quality foods from our partners, restaurants, grocery stores, food distributors and caterers, which would have otherwise gone to waste. Our mission is to help families or individuals that have to choose between paying rent or putting food on the table. Food is also donated to disabled veterans and the elderly citizens who have access only to limited meals. In addition, we are also an animal rescue facility, and support rescue organizations that help homeless individuals with pets. Love Share Rescue Outreach believes that it's important to work in harmony with people and animals.

Article VII - Meetings and Manner of Election

1. Board Meetings shall be held at the principal office of the Corporation or virtually if needed. The location may be changed if a legitimate reason is present.
2. Regular Annual Meeting: A regular annual meeting of the Board shall be held in January of each year at the corporate office, or virtually if needed. The location may be changed if a legitimate reason is present.
3. Notice of Board Meetings: Virtual meetings require 24 hours of notice by any Board Member, while live meetings require 72 hours of notice with 2 or more Board Members in initial agreement to hold it. If a meeting that occurs sooner than that is called and a quorum vote occurs, it's considered binding.
4. Voting: Every Board Member shall be entitled at each meeting and upon each proposal presented at each meeting to one vote.
5. Quorum: 3 Board Members must be present to create a quorum.
6. Proxies: Board Members will have the right and are entitled to vote by proxy appointed by written instrument. Proxy agreements last forever until revoked.

Article IX - Vacancies and Removal

1. Bibi Moore is the Permanent Executive Director until she resigns.
2. Elections and Appointment: Directors shall be appointed by Bibi Moore, and reelected annually.
3. Any Director may also hold the position of Treasurer.
4. Vacancies: If any Director position becomes vacant the Executive Director shall appoint someone to the vacancy.
5. Removal of Directors: Directors may be removed for cause with specifics in the Bylaws.
6. Resignation: Any director may resign at any time with written notice to the Executive Director or the President. The resignation shall be immediate.

Article X - Limitations

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its Board Members, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable payroll or compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under I.R.C. §501(c)(3), or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section I.R.C. §170(c)(2), or the corresponding section of any future federal tax code.

Article XII - Dedication of Assets

Upon the dissolution, termination, or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section I.R.C. §501(c)(3), or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
