ARTICLES OF INCORPORATION

Pursuant to Chapter 617, Florida Statutes, the Florida Not-For-Profit Corporation Act, the undersigned being of full age, for the purpose of forming a not-for-profit corporation without capital stock, does hereby accept all of the rights, privileges, benefits and obligations conferred and imposed by said law and does hereby make, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I NAME

The name of this Corporation shall be Strong Schools, Stronger Hillsborough, Inc.

ARTICLE II PRINCIPAL OFFICE

The street address and mailing address of the principal office of this Corporation shall be located in the County of Hillsborough at 101 East Kennedy Boulevard, Suite 2800, Tampa, Florida 33602.

ARTICLE III TERM OF EXISTENCE

The duration of this Corporation shall be perpetual until dissolved according to law.

ARTICLE IV CORPORATE PURPOSES

The Corporation is organized and shall be operated exclusively for not-for-profit purposes as contemplated by Chapter 617, Florida Statutes. The Corporation is authorized to exercise such powers as are in furtherance of the purposes for which a corporation may be formed under the Florida Not-For-Profit Corporation Act. The Corporation is classified for tax purposes as an organization qualifying as exempt under Section 501(c)4 of the Internal Revenue Code of 1986, as amended.

The Corporation may indemnify the incorporator, any officer or director, or any former officer or director, to the fullest extent permitted by law.

ARTICLE IX
DISSOLUTION

Upon any dissolution of the Corporation, the directors of the Corporation shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner or to such organization or organizations organized and operated exclusively for non-profit purposes.


