AMENDED AND RESTATED ARTICLES OF INCORPORATION OF 50 WAYS FOUNDATION INC.

(Pursuant to Florida Not For Profit Corporation Act)

50 Ways Foundation Inc., a corporation organized and existing under and by virtue of the provisions of the Florida Not For Profit Corporation Act (the "Act"), does hereby certify:

- 1. That the name of this corporation is 50 Ways Foundation Inc., and that this corporation was originally incorporated pursuant to the Act on April 12, 2022 under the name 50 Ways Foundation Inc.
- 2. That there are no members. These Amended and Restated Articles of Incorporation were duly adopted by the Board of Directors on October 16, 2024.
- 3. That pursuant to the provisions of sections 617.1006 and 617.1007, Florida Statutes, this Florida Not For Profit Corporation adopts the following Amended and Restated Articles of Incorporation, which supersede the original articles of incorporation and all amendments to them:

ARTICLE I

The name of the corporation is 50 Ways Foundation Inc. (the "Corporation").

ARTICLE II

The street and mailing address of the principal office of the Corporation is 1131 Campus Drive West, Morganville, N.J. 07751.

ARTICLE III

The Corporation is organized and shall be operated exclusively for exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, as it may be amended ("Code"). In furtherance of these purposes, the Corporation may engage in any lawful act for which corporations may be organized under the Florida Not For Profit Corporation Act.

No part of the net earnings of the Corporation shall be distributed to or inure to the benefit of its members, directors, officers, or other private persons, except that the Corporation may pay reasonable compensation for services rendered to or for the Corporation and make payments and distributions in furtherance of the purposes of the Corporation.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation in a manner or to an extent that would disqualify the Corporation for tax exemption under section 501(c)(3) of the Code. The Corporation shall not participate or intervene in (including the publication or distribution of

statements concerning) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this certificate of incorporation, the Corporation shall not carry on any activity that is not permitted to be carried on by (i) an organization described in section 501(c)(3) of the Code or (ii) an organization the contributions to which are deductible under sections 170(c)(2), 2055(a)(2) or 2522(a)(2) of the Code.

ARTICLE IV

Directors shall be elected by the Board of Directors in the manner provided in the bylaws.

ARTICLE V

The name and Florida street address of the registered agent is Corporation Service Company, 1201 Hays Street Tallahassee, FL 32301.

ARTICLE VI

The Corporation is organized as a not-for-profit corporation and shall not have any capital stock.

ARTICLE VII

Upon dissolution, after payment of all valid debts of the Corporation and necessary expenses thereof, or provision for same, all the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Code, or to U.S. federal, state or local governments for a public purpose.

ARTICLE VIII

Notwithstanding any other provision of this certificate of incorporation, at any time during which the Corporation is a private foundation within the meaning of Section 509(a) of the Code, the Corporation shall distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Code; shall not engage in any act of self-dealing as defined in section 4941(d) of the Code; shall not retain any excess business holdings as defined in section 4943(c) of the Code; shall not make any investments in a manner as to incur tax liability under section 4944 of the Code; and shall not make any taxable expenditures as defined in section 4945(d) of the Code.
