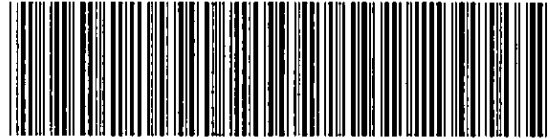

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I
Name**

The name of the Corporation is: Community Life Church, Inc.

**ARTICLE II
Principal Address**

The street address of the principal office of the Corporation is 4115 Soundside Drive, Gulf Breeze, Florida 32563.

**ARTICLE III
Purpose**

The nonprofit corporation is a religious corporation. It is organized as a local interdenominational Church exclusively for religious purposes.

The Corporation is to be operated exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of its charter, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

Powers and Directors

The Directors/Trustees shall be elected as stated in the bylaws. The business of this Corporation shall be conducted in conformity with the bylaws of the Corporation.

The Corporation assumes for itself all the rights, powers, privileges and immunities which are now, and which may be during the existence thereof be conferred by law upon a corporation with a similar character.

At no time shall any of the amendments, bylaws, or regulations of the Corporation be prohibited by or in conflict with the nonprofit corporate laws of the state of Florida.

Term


