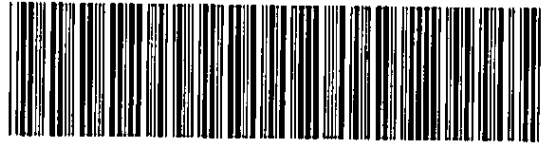

of Ukraine for the purpose of Reconstruction of Infrastructure, Hospitals, Institutions and Housing damaged or destroyed

due to the war with Russia.
