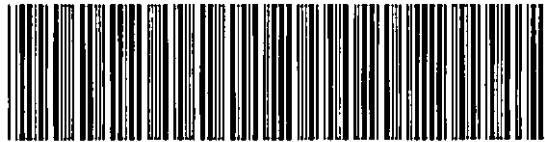

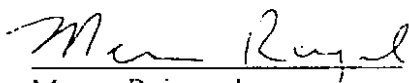
**NOW BE IT RESOLVED:**
