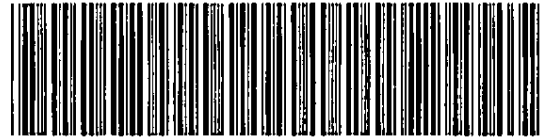

## ARTICLES OF INCORPORATION

### THIS IS JAMAICA FOUNDATION, INC.

The undersigned incorporators, who are individuals 18 years of age or older, a majority of whom are citizens of the United States and pursuant to the nonprofit corporation laws of this state, hereby adopt the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of this corporation is: THIS IS JAMAICA FOUNDATION , INC.

#### ARTICLE II. REGISTERED OFFICE

The principal office for this corporation shall be:

#### ARTICLE III. REGISTERED AGENT

#### ARTICLE IV. DURATION

The duration of the corporate existence shall be perpetual until dissolution.

#### ARTICLE V. PURPOSE

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE VIII. MEMBERSHIP**

This corporation shall have members. The eligibility, rights and obligations of the members will be determined by the corporation's bylaws. The management of the affairs of the corporation shall be vested in a board of directors, as defined by the corporation's bylaws.

All members, officers, directors, and trustees of the foundation shall be active members of with which the foundation is associated.

The classes, rights, privileges, qualifications, and obligations of members of this corporation shall be fixed by the bylaws of this corporation.

#### **ARTICLE IX. COMPLIANCE WITH IRS**

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### **ARTICLE X. PRIVATE BENEFIT PROHIBITION**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

#### **ARTICLE XI. POLITICAL ACTIVITIES**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

#### **ARTICLE XII. LIABILITY**

No member, officer or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or directors be subject to the payment of the debts or obligations of this corporation.

#### **ARTICLE XIII. DISSOLUTION**

Upon the dissolution of the corporation, assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

#### ARTICLE XIV. AMENDMENTS

These articles may be amended at any meeting of the membership of the corporation of which a quorum is present by affirmative vote of two-thirds (2/3) of the members present and voting provided at least 14 days' previous notice of the meeting and each proposed amendment has been given to all members of the corporation. There shall be no voting by proxy or absentee ballot.
