### ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

#### ARTICLE I-NAME

The name of the Corporation shall be: GRANDMA'S HANDS FOUNDATION, INC

#### ARTICLE II-PRINCIPAL OFFICE

The principal street and mailing address: 10335 NW 50th Court, Coral Springs, FL 33076.

#### ARTICLE III-PURPOSE

The purpose for which the corporation is organized is: exclusively for charitable, educational religious, community and literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations.

To this end, the corporation shall exist:

- (a) To establish a prototype system of education that effectively empower children to identify their purpose and fulfill their educational goals while promoting spiritual growth, high standards of scholastic achievement and excellence in the arts and sciences, all housed in a technologically advanced state-of-the-art learning facility infused with a comprehensive and rigorous academic curriculum implemented by dedicated, well-paid professionals in a nurturing environment established on the fundamental Biblical principles of self-control and unconditional love.

corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;

- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and
- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
- 4. The corporation shall not lend any of its assets to any officer or director of this corporation [unless such loan program is regularly conducted as part of the activities of the organization and the qualification of the individual to participate in same is determined by a panel comprised solely of non-Board members], or guarantee to any person the payment of a loan by an officer or director of this corporation.
