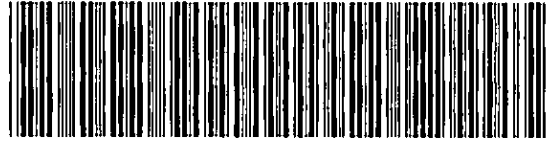

FOR

The undersigned incorporator, for the purpose of forming a corporation, under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: CORPORATE NAME

The name of the corporation shall be:

ARTICLE II: PRINCIPLE PLACE OF BUSINESS

The principle place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSE

The purpose for which this corporation is organized, is to provide creative play for children that develops the skills they need to expand their physical, emotional, social, and cognitive activities. Structured play to help develop pride and confidence in their skills and abilities to create. Provide an atmosphere to keep children active as we believe "Play is Therapy."

Amazing Development with Children Enrichment Services shall be a non-profit corporation and is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
