#### ARTICLE I - NAME

A. Name. The name of the corporation is Faith Church Miami, Inc.

### ARTICLE II – PRINCIPAL ADDRESS

A. The principal place of business and mailing address of the corporation is as follows:

#### ARTICLE III - PURPOSES

- A. The corporation is a Religious Corporation and is not organized for the private gain of any person. It is organized pursuant to Chapter 617, Florida Statutes (F.S.) exclusively for religious purposes, with no stock issued or to be issued, in accordance with the laws of the State of Florida.
  - The specific purposes for which the Church is organized are: (1) to glorify God by making, maturing, and mobilizing disciples of Jesus Christ: (2) to engage in such religious activities as are permitted to be carried on by a Church exempt from federal income tax under§501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law): (3) to accept donations and contributions for all the foregoing purposes; and (4) to do any and all other things necessary or incident to the above and foregoing purposes and powers and including all of the rights, powers and authority incident to general nonprofit corporations organized under the laws of the State of Florida pursuant to Chapter 617, Florida Statutes (F.S.).
- B. No part of the net earnings of the Church shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Church shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation. Nosubstantial part of the activities of the Church shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Church shall not participate in or intervene in (including the publishing or distribution ofstatements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles of Incorporation, the Church shall not carry on any other activities not permitted to be carried on (a) by a Church exempt from Federal Income Tax under §501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future federal tax code.

#### ARTICLE IV - DISSOLUTION

A. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of \$501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
