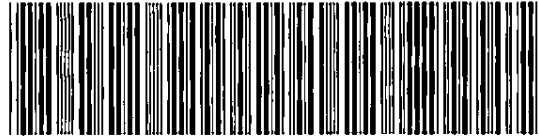

**ARTICLES OF INCORPORATION  
FIRST METHODIST CHURCH OF WILLISTON, INC. TALLAHASSEE, FL**

SECRETARY OF STATE

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a nonprofit corporation.

**ARTICLE I**

The name of the Corporation is: First Methodist Church of Williston, Inc.

**ARTICLE II**

The existence of the Corporation shall begin on the date these Articles of Incorporation are accepted by the Florida Department of State, as evidenced by the department's endorsement of the date and time of filing.

**ARTICLE III**

The street address of the principal office of the Corporation is: 213 West Noble Avenue, Williston, FL 32696.

**ARTICLE IV**

The specific purpose for which the Corporation is organized is: Church Ministry.

**ARTICLE V**

The initial street address of the Corporation's registered office is: 248 NW Main Street, Williston, Florida, 32696. The initial registered agent for the Corporation at that address is: Woodroe Blake Fugate.

**ARTICLE VI**

The directors shall consist of the Administrative Council as elected and appointed as set forth in the bylaws.

**ARTICLE VII**

The Corporation is to be operated exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE VIII**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or

organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


