**ARTICLES OF INCORPORATION ATTACHMENT**

**ARTICLE III - ADDITIONAL PROVISIONS**

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes. The making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

**The specific purposes for which this corporation is organized are:**

To provide low cost or free legal immigration assistance, education and affordable quality legal representation to low income and indigent immigrants.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles this corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation except from federal income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (ii) by corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue code.

Upon dissolution of this corporation its assets remaining after payment or provision for payment of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for a public purpose.
