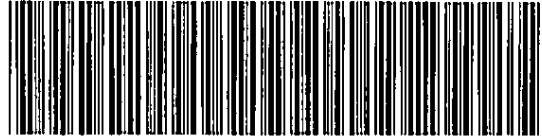

Global Girl Boss Foundation, Inc. is organized exclusively for charitable, educational, and scientific purposes, including for

such purposes, making distributions to other organizations under section 501(c)(3) of the internal revenue code or

corresponding section of any future federal tax code. Global Girl Boss Foundation, Inc. will provide educational materials,

funding for classes, mentorship, and financial assistance for female entrepreneurs as a part of its charitable and educational

purposes. No part of the net earnings of Global Girl Boss Foundation, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this purpose clause.

Adding Article IX

Article IX - Dissolution Clause

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
