

**ARTICLES OF INCORPORATION
(Not for Profit)
OF**

THE LEVELED TABLE, INC.

Article I -- Name

The name of the Corporation shall be The Leveled Table, Inc.

Article II -- Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The specific purpose for which this Corporation is organized is to provide temporary food relief to those who are impacted by situational or personal calamities. The Corporation recognizes that individuals may not be able to feed themselves sufficiently after being subjected to a calamitous life event. These events may include loss of a job, a medical emergency, or another event which could impact a person's ability to feed himself or his family. Accordingly, the Corporation will endeavor to provide food relief on a temporary basis to such individuals within South Florida and other geographical areas.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article IV -- Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.
