ARTICLES OF INCORPORATION (Not for Profit)

THE LEVELED TABLE, INC.

Article I - Name

The name of the Corporation shall be The Leveled Table, Inc.

Article II - Address of Corporation

Article III - Purpose

The specific purpose for which this Corporation is organized is to provide temporary food relief to those who are impacted by situational or personal calamities. The Corporation recognizes that individuals may not be able to feed themselves sufficiently after being subjected to a calamitous life event. These events may include loss of a job, a medical emergency, or another event which could impact a person's ability to feed himself or his family.
