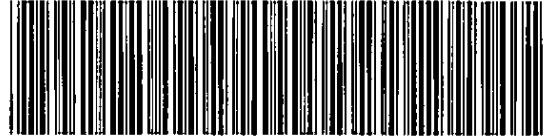

Article III changes: The specific purpose of the corporation is to support the students and director of the Stranahan High Scho
recruiting volunteers, organizing programs, and raising funds to enhance the music, social, performance and competitive
experiences. The corporation is organized and will be operated exclusively for charitable and educational purposes within
the meaning of the 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b)
by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the

corresponding section of any future federal tax code.

Add Article IX Additional Provisions:

In pursuance of its purposes, the corporation shall do all things necessary, proper and consistent with maintaining tax exempt status under section 501(c)(3).

No part of the net earnings of the corporatin shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or coporation having a personal or private interest in the corporation. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and this corporation shall not interever in (including the publishing or distributing of statements) any poitical campaign on behalf of or in opposition to any candidate for public office. Nothwithstanding any other provision of these Articles or of any Bylaws adopted thereunder, this corporation shall not take any action not permitted by the laws which then apply to this corporation.

Under dissolution of the corporation, its assets shall be disposed of exclusively for the purposes of the corporation or distributed to such organizations organized and operated exclusively for charitable purposes which shall, at the time, qualify as exempt organizations under section 501(c)(3), or shall be distrubuted to federal government, or state or local government, for public purpose.

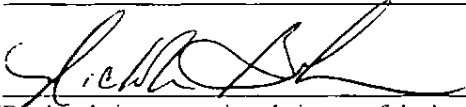
