Articles of Incorporation Of

(In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Proxity Cultural, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 1750 SE North Buttonwood Dr., Port St Lucie, Florida 34952. The initial registered agent of the Corporation at such address shall be: John Nibbs.

Article 3.
