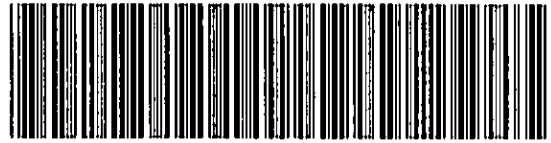

- a) Facilitates educative care for orphan children under thirteen whose parents had passed away
 - b) Provides spiritual light for those in darkness, lacking the light coming from biblical truth
 - c) Restores to inspiring existence level for persons of all ages who are in dire need of restoration
 - d) Facilitates medical, educational and humanitarian restorative care of communities in dire need
 - e) Do all other things necessary for operations and administration of the above


