ARTICLES OF INCORPORATION OF

WF, the undersigned, hereby associate ourselves for the purpose of becoming a not-for-profit corporation under the laws of the State of Florida and are therefore bound by State Statutes regulative information, liability, rights, privileges and immunities of a not-for-profit Corporation.

ARTICLE I Name of Corporat<u>ion</u>

The name of this corporation is FAMULY OF JESUS CURIST GROUP, 1840.

ARTICLE II Purpose
