The undersigned incorporation, for the purposes of amending current Articles of Incorporation in the State of Florida filed with the Secretary of State on July 01, 2022 under N22000007528, hereby adopts the following Amendments to the original Articles of Incorporation:

Organization Purpose**

**Section 1. IRC Section 501(c)(3) Purposes**

This Corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c )(3 ) of the Internal Revenue Code. Including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c )(3) on the Internal Revenue Code.

**Section 2. Specific Objectives and Purposes**

This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. No Substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustee, directors, officers or other private persons, except according to corporation bylaws. The specific purpose for which this corporation is organized is to be vessels for Christ to help people to become resilient, empowered, and transformed through education, community, resources, and Agape love.

Upon termination or dissolution of the Riptide Resiliency and Empowerment Center Inc., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute or Bylaws) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of the Riptide Resiliency and Empowerment Center Inc. hereunder shall be selected by the discretion of a majority of the managing body of the Riptide Resiliency and Empowerment Center Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the Riptide Resiliency and Empowerment Center Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

#### **Article IX Amendments**

Subject to the power of the members, if any, of this corporation to adopt, amend or repeal the Articles of this corporation and except as may otherwise be specified under provisions of law, these Articles, or any of them, may be altered, amended, or repealed and adopted by two-thirds (2/3) approval of the Board of Directors.

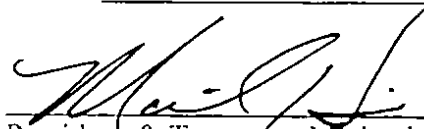

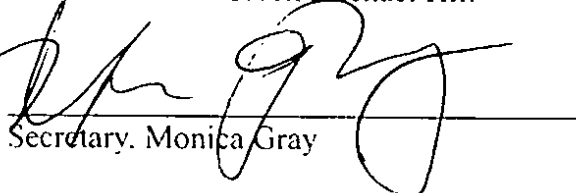

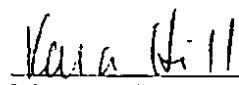
