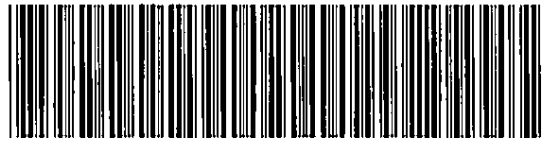

Paragraph two: amended and should read as follows:

Education of elected officials and the public in the state of Florida on the following areas of public policy: criminal justice, affordable housing, insurance, transportation, and other areas of public policy as approved by the board. This education will

be the output of data driven research resulting from networking with relevant subject matter experts, industry leaders, capturing established public policy best practices, and leveraging leading edge technological capabilities. The overarching mission of The Corporation is to positively influence the quality of life for Florida residents and guests. In service of these objectives, The Corporation may also engage in a broad spectrum of activities: invest in, receive, hold, use, and dispose of all property, real or personal, as may be necessary or desirable to carry into effect the aforementioned exempt purposes.

Article V is amended to read as follows:

The Corporation shall exist perpetually unless dissolved according to law. Upon dissolution of the Corporation, assets shall be distributed to a nonprofit fund, foundation, or corporation that is organized exclusively for charitable purposes, having established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a state or local government, for a public purpose.


