- Notes that the global nature of aviation means that States depend on the reciprocal effectiveness of their aviation security systems for the protection of their citizens and nationals, as well as aspects relevant to their national security, and bearing in mind the common goal of the international community in this regard, which means that States depend on each other to provide a common secure aviation environment
