ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

SEASONS AT WEKIVA RIDGE HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1002, Florida Statutes, **SEASONS AT WEKIVA RIDGE HOMEOWNERS ASSOCIATION, INC.**, a Florida not-for-profit corporation (the "Company"), adopts the following amendments (the "Amendments") to its Articles of Incorporation:

1. The name of this Company is SEASONS AT WEKIVA RIDGE HOMEOWNERS ASSOCIATION, INC.
2. The Articles of Incorporation were filed on July 6, 2022, and assigned document number N22000007615.
3. Article 8 of the Articles of Incorporation of the Company is hereby amended by deleting it in its entirety and replacing it with the following:

OFFICERS

The affairs of the Association shall be administered by the officers holding the offices designated in the By-Laws. The officers shall be elected by the Board of Directors of the Association at its first meeting following the annual meeting of the members of the Association and shall serve at the pleasure of the Board of Directors. The By-Laws may provide for the removal from office of officers, for filling vacancies and for the duties and qualifications of the officers. 
