**ARTICLE I
NAME**

The name of the corporation shall be *The Indigo Phoenix Foundation, Inc.*

**ARTICLE II
PRINCIPAL OFFICE**

The principal office of the corporation shall be *815 East Church Street, Bartow, FL 33830.*

**ARTICLE III
PURPOSE**

This corporation is organized exclusively for such nonprofit, charitable and/or educational purposes, and such other purposes as will qualify the corporation as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The purpose of this corporation is to reduce and prevent animal cruelty and animal homelessness by providing low cost or free small animal educational services and foster-based animal rehoming services.

**ARTICLE IV
MANNER OF ELECTION**

The authorized number, qualification and manner of election and appointment of members of the Board of Directors and Officers of this corporation shall be set forth in the Bylaws of this corporation. Initially, there shall be three (3) members of the Board of Directors.

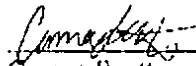

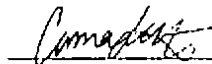

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

DISSOLUTION

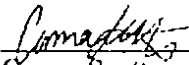
