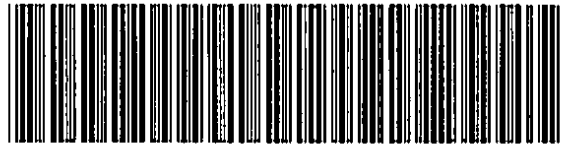

**Article I – Name**

The name of the Corporation shall be Welcoming Wellness, Inc.

**Article III - Purpose**


