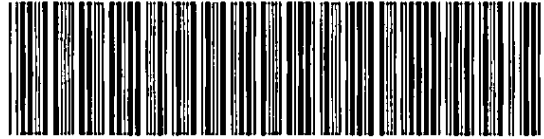

Code, or the corresponding section of any future federal tax code. Specifically, Sonlife is a training organization that trains,

coaches and mentors leaders, providing a fresh encounter with Jesus as our model for making and multiplying disciples

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning

of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed

distributed to the federal government, or state or local government for public purpose. Any such asset not so disposed of shall be disposed

of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose
