

**CHANGE: ARTICLE III to read:**

The Church shall be organized and operated exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any superseding section thereof.

The purpose of this congregation is to give visible form of that faith and fellowship to which God has called His people. We acknowledge ourselves to be a local manifestation of the Universal Church through which Jesus Christ continues to minister to the world by His Holy Spirit. We shall seek to fulfill this calling through corporate worship services, through a program of Christian nurture by which members may be built up in their faith and love, through proclamation of the Gospel by word and deed, and through ministering to human need in the name of Jesus Christ. More specifically:

- (a) Minister the Word of God to the faithful;
- (b) Conduct a religious worship service through various forms of ministry;
- (c) Promote and encourage, through the ministry of the organization, cooperation with other organizations ministering within a community;
- (d) Spread the Word of the Gospel through church services, television, radio and other forms of mass media for the purpose of educating the individual in the Word of God;

This Church is not organized, nor shall it be operated, for pecuniary gain or profit, and it does not contemplate the distribution of gains, profits or dividends to its members and it is organized for nonprofit purposes. The property, assets, and net income of this Church are irrevocably dedicated to charitable, religious and educational purposes.


On the dissolution or winding up of this Church, its assets remaining after payment of, or provisions for payment of all debts and liabilities of the Church shall be distributed to a nonprofit fund, foundation or corporation that is organized and operated for charitable, educational and religious purposes and that has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any superseding sections.
