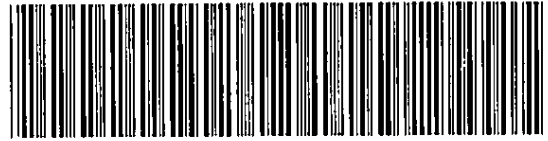

#### ARTICLE VIII

A) Notwithstanding any other provision of these articles, the Company is organized exclusively for one or more of the purposes, as specified in Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code") and shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under section 501(c)(3) of the Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code.

B) No part of the net earnings of the Company shall inure to the benefit of, or be distributable to its members, trustees, director, officers or other private persons, except that the Company shall be authorized to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of its purposes as set forth in these Articles.

C) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

D) In the event of dissolution, all of the remaining assets and property of the Company shall after necessary expenses thereof be distributed to another organization exempt under Section 501(c)(3) of the Code, or to the Federal government, or state or local government for a public purpose.

E) In any taxable year in which the Company is a private foundation as described in Section 509(a) of the Code, the Company shall distribute its income for said period at such time and in such manner as not to subject it to tax under Section 4942 of the Code; and the Company shall not (a) engage in any act of self-dealing as defined in Section 4941(d) of the Code; (b) retain any excess business holdings as defined in Section 4943(c) of the Code; (c) make any investments in such manner as to subject the corporation to tax under section 4944 the Code; or (d) make any taxable expenditures as defined in Section 4945(d) of the Code.


