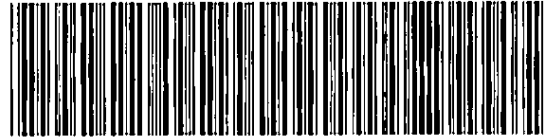

Abadie Academy aims to serve the community by empowering parents with educational choice, students with flexible learning options, and teachers with creative freedom. Our parents are free to choose the homeschool or virtual curriculum of their choice and our teachers provide individualized support.
