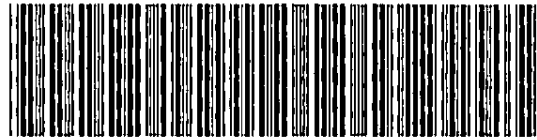

**ARTICLES OF INCORPORATION
FOR
REDEEMED WITH A PURPOSE, INC.**

A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned incorporator (s) for the purposes of forming a corporation under the Florida Business Corporation Act, pursuant to the provisions of Chapter 617, Florida statutes, hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the Corporation is: Redeemed With A Purpose, Inc.

ARTICLE TWO

The Corporation is organized pursuant to the Florida Non-profit Code and the duration of the Corporation shall be perpetual.

ARTICLE THREE

The street address of the registered office is 2424 Eisner Drive Jacksonville, Florida 32218.

ARTICLE SIX

The principal mailing address of the corporation is 2424 Eisner Drive Jacksonville, Florida 32218

ARTICLE SEVEN

The Corporation is a non-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is to:

- (a) To provide an education and training in re-entering inmates back to their community*
- (b) To render all services related to the above*

Provided, however the Corporation shall not engage in any action which is not permitted to be carried on by non-profit corporation under the Internal Revenue Code and no part of it's net earnings of the Corporation shall inure to the benefit of or be distributed to its members, directors, or officers: but the corporation shall be authorized and empowered to pay any reasonable compensations to these people for service rendered, and to make payments and distribute in the furtherance of its stated purposes.

ARTICLE EIGHT

Said organization is organized exclusively for charitable, educational, religious and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE NINE


No part of the net earnings of the organization shall inure to the benefit of, or distributional to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributional in furtherance of the purposes set forth in the purpose clause hereto: No substantial part of the activities of the organization shall be carrying on the propaganda, or otherwise attempting to influence publishing distribution of statement any political campaign on behalf of any candidate for public office. Notwithstanding any other activities not permitted to be carried on by an organization exempt from federal income tax Section 501 C 3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE TEN

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within meaning of Section 501 C 3 of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of by the Court of Common Plea of the County in which the principal office of the organization.

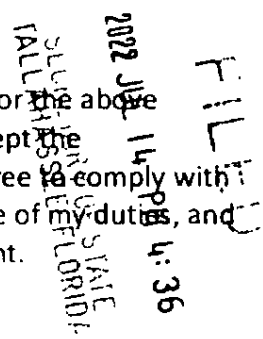
