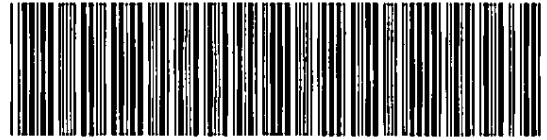

Article VI DISSOLUTION


