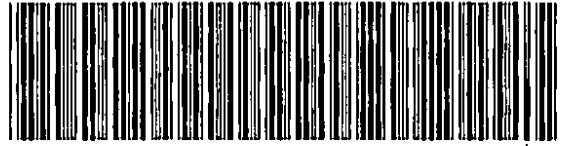

The indemnification provided herein shall inure to the benefit of successors, assigns, heirs, executors, and the administrators of any such person.
