### Articles of Incorporation of

### Black Sheep LMCI Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(6) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(6) of the Internal Revenue Code. The specific purpose of the corporation is: For United States Marine Corp and Navy Corpman active duty and Veterans. To provide combat injury related support in the recovery process. Veterans Organization Marines and Navy Corpmen-Club that volunteers at youth orgs. Motorcycle rides for fallen soldiers. Escort, volunteer. Veterans Affairs. Toys for toddlers.
