**ARTICLES OF INCORPORATION
OF GOSPEL TABERNACLE, INC.
a not-for-profit corporation**

ARTICLE I

Name

The name of the Corporation is Gospel Tabernacle, Inc. (the "Corporation").

ARTICLE II

Principal Office

The principal office and mailing address of the Corporation is:

ARTICLE III

Purposes and Powers

3.1 The purposes for which the Corporation is organized are exclusively charitable within the meaning of the Florida Not-For-Profit Corporation Act, F.S.A. § 617.0301 et seq. The Corporation is organized for the sole and exclusive purpose of owning and administering certain real property and improvements located thereon for the furtherance of the ministries of the Jacksonville Assembly of the Body of Christ (the "Church").

3.2 The Corporation shall have no members.

3.3 No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in this Article.

3.4 Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

3.5 No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

3.6 Subject to the foregoing provisions of this *Article II*, the Corporation shall have all the powers conferred upon a corporation under the provisions of the Florida Not-For-Profit Corporation Act, Chapter 617, Florida Statutes, and any enlargement of such powers conferred by subsequent

ARTICLE IV
Board of Directors/Elders

4.1 Number. The powers of the Corporation shall be vested in the Board of Directors (herein referred to as "Elders"). The number of Elders may be increased or decreased pursuant to the Bylaws of the Corporation, but shall never be less than three (3). The Elders shall be elected pursuant to such procedures as are specified in the Bylaws.

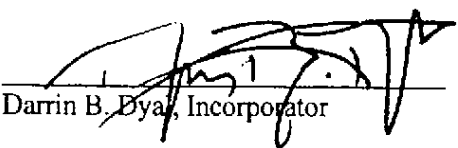
