ARTICLES OF INCORPORATION
OF
YOUTH OF RETURN AFRICA INCORPORATED

ARTICLE I: NAME

The name of the Corporation shall be YOUTH OF RETURN AFRICA herein referred to as YOUTH OF RETURN AFRICA INCORPORATED

ARTICLE III: PURPOSE

The specific purposes of the Corporation is to:

- a) Advance equity in education for students of color and students from low-income backgrounds from elementary through high school and college.
- b) Provide improved educational facilities, opportunities, and conveniences for African students
- c) Promote youth boys' and girls' sports both nationally and internationally to further promote the development of leadership, character, sportsmanship, discipline, tolerance, athletic ability and to nurture youth fitness and a lifelong love of sports.
- d) Unite countries and people of African descent
- e) Empower Africans and people of African descent to reach their full potential
- f) Provide accurate and factual information on African culture and heritage to those in the Diaspora
- g) Provide mentoring, educational programs, technical courses and career development through technology for African underserved youth
- h) Provide more children across Africa with the opportunity to participate in computer science and make it more available in schools throughout the African Region

- i) Increase vegetation cover in African regions while promoting sustainable farming models
- j) Promote more efficient and sustainable agricultural practices through workshops as well as community-based projects
- k) Empower African youth through STEM by providing more workshops, education, mentoring and hands on learning experiences

ARTICLE IV: NON-PROFIT NATURE

The Corporation is organized exclusively for: charitable, educational, agricultural, technological, scientific, and for the purpose of fostering both national and international sports competitions as specified under Section 501 (c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of Youth of Return Africa (YORAFRICA) Incorporated shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, corresponding section of any federal tax code, or (b) by an organization, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Youth Of Return Incorporated (YORAFRICA) is not organized and shall not be operated for the private gain of any person. The property of the corporation is dedicated to its charitable and educational purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of or be distributed by any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these articles.

4.02 PERSONAL LIABILITY

No officer or director of this corporation shall be personally liable for the debts or obligations of Youth Of Return Incorporated of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

4.03 DISSOLUTION

Upon termination or dissolution of Youth Of Return Africa Incorporated, any assets lawfully available for distribution shall be distributed to one (1) more qualifying organizations described

The duration of the corporation is perpetual.
