Amend Article III -

Article III: The corporation is organized exclusively for charitable, educational and civic purposes, specifically to represent the larger Filipino-American community in NE Florida in city-wide programs and services aimed at promoting cultural heritage and diversity, and to celebrate the annual Philippine Independence Day. The organization will not engage in any activities that are not in furtherance of one or more exempt purposes.

Add Article IX -

Article IX: Upon the dissolution of this organization, assets shall be distributed to benefit one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
