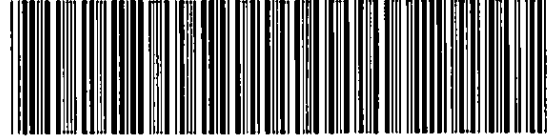

**ARTICLE I. NAME**

The name of this corporation is: **Arcco.Info Inc.**

**ARTICLE II. PURPOSE**

This corporation is a not for profit corporation and is not organized for the private gain of any person. It is organized under the Chapter 617 of The 2022 Florida Statutes for charitable and educational purposes. The specific purpose of this corporation is to provide journalism training, editorial support, journalistic production and events aimed at the promotion and development of transparency in journalism.

This corporation is organized exclusively for charitable and educational purposes within the meaning of Internal Revenue Code §501(c)(3) or the corresponding provision of any future United States internal revenue law. Despite any other provision in these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that do not further the purposes of this corporation, and the corporation shall not carry on any other activities not permitted to be carried on by (i) a corporation exempt from federal income tax under Internal Revenue Code §501(c)(3) or the corresponding provision of any future United States internal revenue law, or (ii) a corporation, contributions to which are deductible under Internal Revenue Code §170(c)(2) or the corresponding provision of any future United States internal revenue law.

## **ARTICLE VII. TAX-EXEMPT STATUS OF CORPORATION**

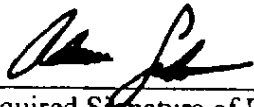

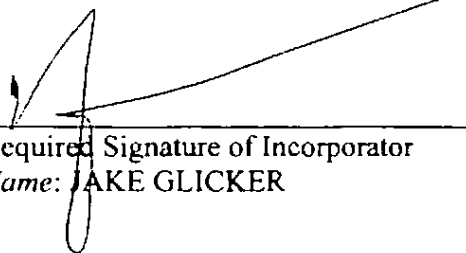
