ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

Pursuant to Chapter 617.1006 of the Florida Not For Profit Corporation Act

REBEKAH NORTON, Secretary of VENETIAN I AT ESPLANADE LAKE CLUB CONDOMINIUM ASSOCIATION, INC., a Florida corporation not for profit ("Association"), does hereby certify under the seal of the Association as follows:

- 1. The Association was originally incorporated on August 16, 2022, Document Number N22000009519, under Chapter 617 of the laws of the State of Florida.
- 2. Article XIII, Section A, of the Articles provides that prior to the recording of the Declaration amongst the Public Records, these Articles may be amended by an instrument in writing signed by the President (or a Vice President) and the Secretary (or an Assistant Secretary) and filed in the Office of the Secretary of State of the State of Florida.
- 3. Article IV of the Articles provides that until such time as Venetian I at Esplanade Lake Club is submitted to condominium ownership by the recordation of the Declaration, the membership of this Association shall be comprised solely of the members of the "First Board" (as defined in Article IX thereof).

Engaging in mandatory non-binding arbitrationalternative dispute resolution as provided for in Section 718.112(2)(a)2 of the Act for the settlement of disputes as provided for in Section 718.1255 of the Act. The provisions of Sections 718.112(2)(a)2 and 718.1255 are incorporated by reference herein.
